## Explanations and comments

Analysts and commentators dealing with economic issues usually focus on data illustrating the current state and changes of the entire Polish economy. This approach is natural. Data generalization allows for easier understanding and easier formulation of projections about the future. However, it should be borne in mind that from the point of view of individual companies, the synthesis of data at the national level is not adequate due to the very different situation and specificity of the industries operating in the country.

The Polish economy is very diverse. Due to the large size and large population, numerous ideas for running a business had a chance to develop in our area. We have a particularly large abundance in this variety in industry, construction, services. This is confirmed by the information presented by official statistics. The differentiation concerns both the potential in terms of sales level, the number of employees, but also the current situation, including the rate of sales growth, the level and dynamics of wages, progress in terms of efficiency.

The intention of the Polish Chamber of Commerce is to support the work of entrepreneurs by presenting them with data on the economic potential and the current economic situation in individual industries. In the study below, the data of the Central Statistical Office have been supplemented with the estimates of the Polish Chamber of Commerce based on GUS data.

The study presents data on the enterprise sector. The widest range of data is available for industry and construction - where the following are presented: the level of sales and the current rate of its growth along with the average productivity of an employee measured by sales per one employee, the level and dynamics of employment, level and dynamics of wages, dynamics of productivity. In the case of other industries, the information concerns the level and dynamics of wages and the level and dynamics of employment.
